Beginning in 1998 with the purchase of 3 ewes from S & T Tunis, my flock has grown to include +35 ewes. My foundation ewes have come from some of the top Tunis flocks of the nation: Barthlomew, Seavey, J & J, S & T, Hotis, and Mayes. I am proud now to say that many of my good flock ewes are "my own breeding"; I now have enough ewe lambs to keep replacements ewes. In 1999 I bought the National Champion Ram at the sale in Syracuse. I now use a son of the 1998 Champion Ram, MTP 3 "Eric", and RQL Farms 1016, "BB", the 2003 National Reserve Champion Ram, as my main herd sires. BB's lambs look really great. He has truly enhanced the wonderful Tunis qualities of my flock. I look forward to seeing the lambs that will carry BB's and Eric's genetics. I feel that my flock will contribute well to future Tunis breeding.

With the support of my family: husband Leon, now retired from the public school system and so spending even more time as the shepherd of our flocks ( $\pm$  35 Tunis ewes and  $\pm$  450 Horned Dorset ewes), daughters Mary Ann, CARD managing therapist, and Diana, accountant, great supporters of all things sheep, and son Paul, attorney, advisor and finder of terrific sheep, I plan to continue the improvement of my Tunis flock. # 2004 TUNIS FUTURITY

Northeast Tunis Sheep Association

The 2004 Tunis Futurity has been developed to encourage and support youth interest in Tunis sheep. Youth have the opportunity to purchase quality ewe lambs and breeders have the opportunity to promote their breeding, showcase their best and to encourage youth interest in Tunis sheep. Sponsored by the Northeast Tunis Sheep Association, the Futurity is open to all consignors and youth purchasers.

Futurity lambs may be purchased at these designated sales:

**National Tunis Show & Sale - May 29 & 30, 2004**

**Wooster, OH**

**Empire Spring Classic - June 5, 2004**

**Cobleskill, NY**

**New England Sale - July 17 & 18, 2004**

**West Springfield, MA**

## CONSIGNOR RULES:

1. Entries are limited to spring ewe lambs born January 1, 2004 and later.
2. Nomination fee is \$25.00 per ewe and payable to: Northeast Tunis Sheep Association. Ewes must be nominated and the nomination fees must have been paid prior to the ewe entering the sale ring; ewes may not be pre-sold but must go through the sale ring at a designated sale. Nomination fees are non-refundable; all nomination fees will go directly to youth participating in the Tunis Futurity.
3. Lambs will be tagged for Futurity purposes after the sale of each sheep. Ewes not tagged on the day of the sale will not be eligible for the Futurity.
4. Ewes must be consigned to one of three designated sales: National Tunis Sale - Great Lakes Sale, Wooster, OH; the Empire Spring Classic, Cobleskill, NY; and the New England Sale, West Springfield, MA.

## EXHIBITOR/PURCHASER RULES:

1. Exhibitor must be a junior who has not reached their 21st birthday by January 1, 2004. There is no minimum age limit, but the junior must be capable of showing their own sheep.
2. Only Futurity nominated ewes purchased through the National Tunis Sale - Great Lakes Sale; the Empire Spring Classic; or the New England Sale qualify for the futurity.
3. The exhibitor/purchaser must physically show their Futurity lamb to qualify for points at each show. If the exhibitor has two Futurity lambs in one class, another junior may show the second animal.
4. Ewe lambs must be registered in the individual exhibitor's name only. No farm, family, sibling, partnership, 4-H club or FFA Chapter names accepted.
5. Ewe lambs and points earned in the Futurity are not transferable to any other persons, nor are points earned in the Futurity transferable from one lamb to another.
6. A Futurity entrant may participate with as many Futurity nominated lambs as they desire, but will receive the year end placing for the ewe with the highest cumulative point total. Each junior may win only one award.
7. Ewes must be shown in their proper age class.
8. Prizes will be distributed to the top 7 different participants as follows: first \$200; second \$150; third \$100; fourth \$75; fifth \$50; sixth \$50 and seventh \$25. If more than \$650 in nominations is received the total received will be distributed and the number of youth receiving prizes will increase up to a maximum of 10.
9. Lambs will be tagged for Futurity purposes at the sale after purchase. Lambs must be tagged at the sale or they will be ineligible for the Futurity. Futurity packets will be given to the participants at the time of tagging.
10. A point card must be completed at each show and the original (no copies) mailed to the Northeast Tunis Sheep Association within 14 days of the show. The card must be signed by the show Superintendent certifying that the junior exhibited the Futurity animal; the card must also include class entered, class size, and the placing of the lamb. Point cards are included in the Futurity packet received at tagging.
11. At each show the animal may earn Futurity points from either the open or junior division but not both.
12. No show placings may be submitted for shows occurring before the National Tunis Show - Great Lakes Sale, Wooster, OH.

## **NATIONAL TUNIS SALE INFO.....**

**13. Ewe lambs may compete at an unlimited number of shows with only their top 5 point award shows being recorded for the Futurity point total. Ties will be broken by awarding the higher prize to the lamb exhibited at the greater number of shows.**

**14. Futurity awards will be announced in October at the New York Bred Ewe Sale, Rhinebeck, NY.**

**15. The sliding scale from which Futurity points will be awarded is as follows:**

## GREETINGS FROM REGION 5.....Don Schrider writes...

I have some very exciting news - I have recently been offered a job with the American Livestock Breeds Conservancy. This means a move to North Carolina for me and it also means that I will not be serving another term as your Regional Director from Pennsylvania. I would like to thank all of you for your support in the last 3 years; it was a pleasure serving as your representative to the Board. I would also like to thank those of you that nominated me for another term of office. It felt good that several of you wanted me to continue.

Things are looking good for our breed. The brochure is finished and contains photos of Tunis from a number of flocks. The breed standard update is complete. The breed scorecard update will soon be accomplished. The constitution and by-laws have been updated. Thanks in part to increased registration and transfer fees the club is sound financially. Interest is ever increasing in these wonderful sheep.

I have read a number of opinions lately in our newsletter and would like to make a few comments of my own. Two newsletters back, Louise published our "Breed Standard in Brief". In this we (I say "we" because I chaired the breed standard revision committee) tried to come up with short descriptions of the most important traits, common, but acceptable faults, and outright disqualification's. Martha Robie is correct that a number of Tunis have been show and even sold that had what I consider foreign color in the red section - black hairs. I do NOT necessarily believe that indicated any recent cross breeding, but rather a failure on the breeders' parts to cull otherwise excellent sheep.

There should be no question in your mind that Tunis today have a colorful and mixed background. It is common knowledge that the original pair was crossed with locally available sheep and it is more than just likely some of these crosses ended up in the gene pool when a formal registry was established. We also know that other breeds were introduced, like the Southdown, along the way to improve meat or wool characteristics.

Our concern should be to take what we have and cull our flocks closely to an idealized standard to improve the overall quality and consistency in our breed. The dark hairs Martha wrote about are certainly a large concern for me because the use of such sheep is breeding away from the desired red color that is the hallmark of this breed. I would much rather use a Tunis with a white blaze down its nose than one with black hairs on its face - but use of either will slow the achievement of developing deep true red color (even though sheep with dark hairs on face and legs appear darker at a distance, they are not as close to the ideal as sheep with a lighter color free of any hint of black.) Let me again remind you that our breed is genetically a black-faced sheep with a modifier gene that suppresses the black and causes it to appear red. When this gene is weak, black hairs show up. This is important because this gene gives our breed its identity and using animals with a weak version of it will cause loss of the primary breed characteristic.

One of the breeders that showed one of the lambs that Martha saw should really know better. But this breeder is not totally to blame as some of the foundation sheep they used are from a line that consistently produces occasional sheep with a gray appearance (because of the black hairs intermixed with the red.) And I have seen examples of this in many flocks over the years. In almost every case, the animals could be traced back to one flock of origin (though it may have been 30 years previous). The other breeder could be as excused as the breed standard update had not been formed yet and they may have simply missed the importance of the fault.

I have also heard of a fairly new breeder proclaiming the superiority of Tunis with some black hairs in face and legs as being darker and thus better - especially for show (as judges are looking for darker red). Well, they are not. A few judges that know nothing of the breed and its genetic makeup may say things along this line, but be assured, following their advice will ruin the true red color.

In short, when the new brochure, or national directory, comes out be sure to read the breed standard and the breed standard in brief and apply these ideas to your flock. Not every ewe is a keeper! We should be learning to breed a richer red color on our sheep but it must be red and not black hairs that give us the richer color.

Now on to Mel Smith's article. Mel made some good points and I, especially, like his ideas about tail docking. But, Mel, you are not being taxed by the show people. The cost of registering a sheep increases the value of that sheep from \$100 - 150 (as a grade mixed breed would bring) to \$250-290. So what if you have 50 ewes and I have 2. Should I be taxed to add value to your sheep? The Board of Directors debated this point and I think the clearest point came from a big breeder out in the Midwest that said, "I think those that benefit most should pay their share." We had to increase either membership fees or registrations/transfers. If you spend too much money registering your sheep to be able to fetch purebred prices, register fewer sheep. Those of us with fewer sheep shouldn't have to bear a bigger percentage - that would be taxing the little guy.

Perhaps Mel also felt that money spent on shows was the cause of the rate increase. Well, it was not. But we must also understand that money spent promoting showing our breed brings it in front of people who do not know it exists and that is the best form of breed promotion. Miki and I saw our first Tunis at a show and we do not show our sheep. We may have gone with a different breed if not for that promotion. I do agree that we should not only advertise our sheep in show publications, and Randy Powley is working on that. The Registry is in the business of breed promotion and showing is one aspect that is economically viable and conducive to breed promotion. This coming from a non-showman!

Perhaps those that feel show-based promotions are costing the club unnecessary expense can offer some thoughts on non-show-based promotion. Without breed promotion none of us will be selling many sheep. Even fewer will be able to charge a fair purebred price. What we need to do is to work together to promote our breed and we need to disseminate information on how we can improve our sheep.

I'd like to repeat my thoughts on expanding The National sale activities over a longer time period so that we could plan a bigger national annual event, so that we would not have to have a meeting on The Sabbath morning, so that there would be more time for the silent auction, so that there could be fun plans for the youth,etc. It should be up to the 'host' group to plan so that it can take best advantage of the local "color" wherever it is held, so that each year we can look forward to different, new fun and more members will be enticed to join in so that we can all become better acquainted.

About the election. I hope that all the new directors who ran unopposed will come to Wooster with definite choices for alternates and that all directors will work with their alternates so that there will always be a backup who is up-to-date on all the issues at all times. Two heads really are better than one as policies are debated and business is planned. Even then, it is not a guarantee Last fall's controversy over proxies was never completely reported. Bob did plan with his alternate, but she couldn't come. Then he thought he probably would make it, but wanted me to cover in case he didn't. He could not find a member in his region who was sure to be there AND was informed about all the business to come up AND would vote how he felt his region wanted him to vote. He planned to put it in writing, but circumstances prevented that at the time. Furthermore, there were several precedents when a proxy had stood in while not residing in the region he represented at the meeting.

Finally, we really need to have a written standard operating procedure for conducting elections in order that the election person does not have to invent the wheel every time. Please no offense to Lyle, it is a thankless job. But there are ways to send and receive ballots with a checkoff list to be sure they are from legal members while also maintaining the anonymity of the actual votes. It has been done previously and prevents any doubts about accuracy.

## THE BREED STANDARD IN BRIEF....List of Faults & Ideal Characteristics

### IDEAL CHARACTERISTICS

Calm Disposition  
Pink nose & tongue (spots or dark acceptable but not ideal)  
Pink skin  
Slender face, wider at muzzle  
Muzzle deeper than it is wide  
Long pendulous ears which droop.... forward at rest: pointed forward when alert  
Tan to red face

### Judy Harris, NTSRI Clerk writes....

Here's a few instructions when filling out your registration form and transfers:

#1 The registration forms have to be filled out for new registrations only. If you are registering older ewes with the new lamb crop...please put them on the form starting with the oldest first.

#2 When doing transfers, no form is necessary. Just fill out the back of the official registration and send it to me. It is very important that the transfer is signed by the seller and dated with the date you bought the sheep. Please make sure that the new owner is listed exactly how you want it to appear on the registrations.

#3 If you buy a bred ewe, you are listed as the owner of the new lambs on the registration form, but not the breeder. The breeder is the person you bought the bred ewe from.

#4 If you have already sold the lamb before you register it, you can register and transfer that lamb at the same time. It has to be treated like a regular registration. You are the breeder and the owner. In the column on the far right of the registration form, put who you sold the sheep to and the date of the sale. The date of the sale is very important. The price for this process is \$8. (\$4 for the registration and \$4 for the transfer.)

#5 Remember the Board of Directors voted as of February of 2003 to increase the amount of registrations and transfers to \$4 each. The membership fee remains the same at \$10. The price increase was due to the increase in the postal rates. We still have lower fees than most of the other breeds. Hopefully, we can stay at these fees for a while. Our increase in 2003 was our first since 1992.

#6 Filling out the registration form. Please be very careful to fill in all the appropriate columns. Flock Name - must be filled out and be only 12 spaces.

Number - This is the tattoo or ear tag number given to each sheep.

Sex - ram or ewe.

Date Born - Very important...make sure and give the year, too.

Type - Single, put S; Twin, put TW; Triplet, put TR.

Sire - Name and Flock Number and the NTSRI number - this number is very important, please double check that number.

Dam - Name and Flock Number and the NTSRI number.

Ownership Transfer - to be filled out only if the animal is sold. Please take extra time and double check all your information to make sure it is correct. If you have any questions when filling out this form, don't hesitate to call

#7 Rush Work and Routine Work - Please put rush work and routine work in separate envelopes. Mark Rush on the outside of the envelope. Rush work is usually 7 to 10 days. Routine work is 21 days. Please allow delivery time. It usually takes 3 or 4 days for me to receive your envelope and then another 3 to 4 days in the mail again.

## **CATHARINE JOHNSON OF KEARNEYSVILLE, WV...writes in an e-mail to Jozi Best....**

I applaud the National Tunis directory, the newsletters, and the articles showing up all around. I want more information about Tunis.

I am responding to your request for information about where we are planning to exhibit Tunis. I think the article is much needed. Only a small portion of the members names are showing up in the newsletter as participating in the show ring. There are a lot of reasons for this and all need to be recognized. The lack of attending national shows should not be viewed as a negative for our breed. There is a place for all of us. How many members attend the national shows and meetings without their sheep? I think the members ARE showing their sheep locally and need an avenue to tell about it.

I find that local exposure is the best for Southwood Farm Forge. We hold a studio tour/farm day the 2nd weekend of November each year at our farm with an attendance of 500 cars. We host several workshops during the year. Our farm is also the home of a Blacksmith shop. We promote heritage tourism, conservation genetics, American heritage rare breeds, conservation agriculture, American history, and education. Our sheep are Tunis.

Your request for this directory has intrigued some thoughts. Communication and education are keys to the strength of the NTSRI organization and the breed. I find the member contributions to the newsletter to be very helpful. Sometimes I do not understand the information in the newsletter because I have not attended a Tunis show or meeting. I am confident that this will improve with time. It is good to hear about each others methods, trials, and successes. The folks that purchase breeding sheep need this information. A survey of new buyers would probably show that some are new at farming. Farms are disappearing by the thousands and a few good hearted people are holding on by a thread....

Future topics that I would like to see discussed more are genetic information, Tunis history, where were the flocks 10 years ago? 20 years ago? Parasite control and marketing data. How many Tunis are sold each year as breeders? How many are sold as market lambs? What are the flock sizes? How do we rate on the Scrapie Flock statistics? Do we carry the Scrapie gene in our genetics? Is anyone having trouble with processing and marketing the meat or wool? These are just a few of my curiosities.

Our family schedule and budget does not lend itself to traveling and showing sheep away from home. My plea to the NTSRI is more promotional materials, brochures, posters, and pertinent items that can be used to promote the breed here at our home. The newsletters' financial report showed income but did not note expenses of the organization. I support the competition shows, however, with 264 members I suspect that we all could benefit from promotional materials. Some of the show money could help my local show by providing promotional items. A PDF file of the logo would be a good start. This directory will go a ways to help, too.

To summarize this email, Communication and information transfer is key to this organization. Promotional materials, pedigree/registry information, the newsletters, magazine articles, internet, and membership support are the most important tools that NTSRI has to offer. I think the competition shows are important, however, my farm and my customers benefit more from the communication and local promoting. I suppose MA and OH started as a small local concept and then geographical enhanced with the location of the National Shows. Once more of us become great at local promoting, we could host a National show in our region.
