- It was decided that the new Tunis Brochure will be the same as the past brochure, with a trifold look that can be inserted into a pocket, and Kathy will work with the rebranding committee for a cohesive look consistent with the new look and message for the content and design of the brochure.

## Old Business:

NTSRI Directory follow-up.

- The Directory Committee will be made up of Kelly, Dan, Debbi, and Lloyd they will schedule a meeting the first week of September to work on a price for Ads. Ads will be sold by October 1, and the Directory will be ready to be published by November.
  - We need a name for the Directory.
  - This topic will be the focus for the next meeting.

- There will be 2 issues a year. One in Spring due by March 15<sup>th</sup> for the April issue, and one in Fall with an October 1, deadline.
- A price break will be offered if a member places an ad in both editions. The fee must be paid at one time.
- Payment for Ads will be required before publication.
- Associated Registry will not register or transfer sheep for any member who has not paid their ad fee in full.
- Dana will follow up on a quote from AR on the cost of creating a Digital database for NTSRI.
- The Social Media committee will be headed up by Jessica Vandenbroek, Kylie Schakel and Mackenzie Smith will also serve on the committee with Justine. Kathy will participate in conjunction with Brochure creation.
- Jessica discussed different companies and their specific abilities to help with rebranding, and website creation.
- The Social Media Committee will meet to discuss the options and present their findings at the September 7<sup>th</sup> BOD meeting.

### New Business:
